Mesh Assist's currently does not collect information relating to clients in any other format than normal business-related practices – such as in name and address files which are stored electronically on personal hard drives. This information is not available to any other party for any purpose.

However, Mesh Assist's does store information collected by clients on Mesh Assist's servers. Such information is protected from unauthorised access via:

Firewall access provisions,

Password protected selective data access.

Mesh Assist's will never use information stored for clients for any use other than that which is required for the provision of the services for which we are contracted by said clients.

Mesh Assist's respects the rights of individuals to determine to whom they give their personal information and how this information is used. Any information which is collected from time to time is available to clients upon request.

If Mesh Assist's does undertake to collect information about clients or potential clients we will be open with such people as to the kinds of personal information we hold and what we do with it. We will strive to ensure that information about such people is accurate when we collect or use it. Wherever possible and appropriate we will let them see the information we hold about them and correct it if it is wrong. If we do not grant them access to their personal information we will tell them why.

We will keep their information secure. Only properly authorised people are permitted to see or use it. We will take steps to protect their privacy if we send personal information about them anywhere.

When we no longer use their information we will take care to properly de-identify it or destroy it.
